2. **Objectives**

2.1 Overall Objective:

The main objectives to be achieved by this project are, first of all, the growth of agricultural production and stability of producers' incomes, as well as an increase of competitiveness while adapting to the requirements of domestic and foreign markets and the technical and technological progress of the agricultural sector

2.2 Specific objective:

The specific objective of the project is to strengthen the capacities of the Ministry of Agriculture, Forestry and Water Management (MAFWM) regarding the implementation of the Common Market Organization mechanisms, in line with the EU acquis.

2.3 The elements targeted in strategic documents i.e. National Development Plan/Cooperation agreement/Association Agreement/Sector reform strategy and related **Action Plans**

The attainment of results proposed under this project will contribute to the fulfilment of multiple priorities defined in strategic documents.

Stabilisation and Association Agreement (SAA)

The Article 97 of the Stabilization and Association Agreement stipulates that cooperation between the Parties shall be developed in all priority areas related to the Community

acquis in the field of agriculture, as well as veterinary and phytosanitary domains. Cooperation shall notably aim at modernizing and restructuring the agriculture and agroindustrial sector, in particular to reach community sanitary requirements, to improve water management and rural development as well as to develop the forestry sector in Serbia and support the gradual approximation of Serbian legislation and practices to the Community rules and standards. Article 1, Section 2 (d) of the SAA states that the aim of the Association established is "to support the efforts of Serbia to develop its economic and international cooperation, including through the approximation of its legislation to that of the Community".

EC progress report for Serbia 2020

In the EC progress report for Serbia 2020, under Chapter 11 Agriculture and rural development in the area of the common market organization - it is stated that the horizontal law has yet to be adopted through secondary legislation in areas including marketing standards, public and private storage, and producer organization spending as a result. This delay should be addressed so that the acquis alignment plan can proceed.

Agriculture and Rural Development Strategy for 2014-2024

Some of the goals stated in the Strategy of Agriculture and Rural Development of the Republic of Serbia for the period 2014-2024 are:

- 1) production growth and income stability of producers;
- 2) growth of competitiveness with adjustment to the requirements of domestic and international market and technical technological improvement of the sector;

This Twining will contribute to the achievement of these strategic goals and improve agricultural production through the provision and implementation of an appropriate legal framework for the establishment of the Common Market Organisation (CMO).

National Plan for the Adoption of the Acquis (NPAA)

Market mechanisms in Republic of Serbia are not in line with the measures of the common market organization in the European Union (EU). In Serbia, there is no single legislative framework for implementing most EU measures for regulation of the market of agricultural products. RS has a functioning market. The RS government is implementing certain measures to influence the market. Some of the market regulation measures exist, but are not compatible with the Union acquis, such as market ones standards, trade policy measures relating to trade with third countries and market information system. There are also certain measures that are partially compatible with the EU acquis such as in the field of viticulture and winemaking. In order for Serbia to be able to implement measures in its system, which refer to the regulation of the market of agricultural products, it is necessary to establish a single legal basis. A key regulation in the EU, with which it is necessary to harmonize domestic legislation in this area is Regulation (EU) No1308/2013 of the European Parliament and the Council of 17 December 2013 on the establishing of a common organization of the market in agricultural products. MAFWM recognized the importance of enacting legislation, based on which various measures would regulate the markets in certain sectors of agricultural products and create conditions for activating certain market regulation measures, with the aim that at the time of EU accession, there is a legislative and institutional framework necessary EU mechanisms, relating to the common organization of the market in agricultural products.

Planning measures for the period 2018 – 2021 under NPAA

Under NPAA is planned adoption on Law on Organization of Agricultural Products Market. This law will define various requirements and measures for the organisation of certain sectors of the market of agricultural products, will create conditions for initiating certain measures for market regulation and define the competencies and the roles of other institutions than MAFWM that will be in charge of implementing certain measures market

EU regulations with which harmonization is performed:

 Regulation (EU) no. 1308/2013 of the European Parliament and of the Council of 17 December 2013 on the establishment of a common organization of the market in agricultural products and repealing Council Regulation (EEC) no. 922/72, (EEC) no. 234/79, (EC) no. 1037/2001 and (EC) no. 1234/2007;

Expected degree of harmonization with EU regulation:

The law on Organization of Agricultural products market partially in line with Regulation (EU) no. 1308/2013, on the establishing a common organisation of the markets in agricultural products while complete compliance is expected by the date of accession RS' to the EU membership.

3. Description

3.1 Background and justification:

Common Agricultural Policy of the EU is an oldest common policy (introduced by Roma Agreement of 1958) and the policy that decisively determined not only the development of agriculture in Europe but also the shape and dynamics of the whole process of EU integrations. It represents a complex system of legal acts and support schemes which are implemented across the EU by every member state, and therefore alignment with it and creation of conditions for its effective implementation is one of the key prerequisite for every country aspiring to become an EU member. The CAP consists of two pillars, one of which relates to direct payments and market measures and the other dealing with the rural development policy.

Given complexity of the process of preparing the candidate country for the implementation of CAP it can be concluded that it represents a challenge for the Republic of Serbia, one that can be overcome by timely execution of preparatory activities and well-structured and aimed pre-accession assistance.

In the broader context of preparation for the implementation of Common Agricultural Policy, the candidate country, among other, needs to harmonize its legislation with the acquis regulating CMO as well as introduce and strengthen the institutional framework required for the implementation of CMO measures. In that respect the Republic of Serbia will be required to establish a fully operational system for the implementation of Common Market Organization prior to acquiring EU membership status. Regarding the alignment with the acquis in the area of Common Market Organization, after explanatory screening for Chapter 11, the Republic of Serbia recognized the necessity for preparing a Road map for transposition and implementation of EU requirements for CMO, which has been done Republic of Serbia prepared an Action plan covering all aspects of alignment

with the acquis in Chapter 11 accompanied with requirements and plans with respect to strengthening the human resources in MAFWM and estimated budgetary expenditures.

In the domain of agricultural markets in recent years Serbia started with the adoption of laws and bylaws which are in line with the European legislation that regulates the common organization of agricultural markets (namely with Council Regulation (EC) No 1308/2013). This process is particularly advanced in the wine sector.

In addition preparations are underway for systematic regulation of this field in line with EU policy, and with view to that a Law on organization of agricultural markets—was adopted in June 2021 (Official Gazette of RS No 67/21). This will improve the situation to an extent by advancing the process of alignment with EU acquis, and creating a solid base for future activities in this field. Apart from passing of the appropriate laws and bylaws harmonization in this area will also entail the preparation for the implementation of the said regulative which will be performed through the capacity building aimed at competent administrative structures.

The establishment and implementation of CMO is of high importance for the Republic of Serbia. This is significant in order to properly regulate domestic market and make it compatible with EU requirements, which will lead to market stability and availability of adequate mechanisms to be applied in case of market disturbances. Apart from that the introduction of CMO rules to Serbian legal framework will contribute to attainment of defined standards in certain sectors, enforcement of certain obligations on the producers but also providing them with additional right, all with view to regulating the whole market chain (contractual relationships, uniform buy/sell criteria, reporting, maintaining registers etc.)

The above stated is not only a priority with respect to preparation of the Republic of Serbia for the membership in the EU but will also bring about positive changes when it comes to improving the competitiveness of Serbian agricultural products both on domestic and foreign markets.

Taking into account the complexity of the process of establishment of functional CMO system in the Republic of Serbia with regard to both legal and institutional aspects, as well as the time constraints Serbia faces, pre-accession assistance will be required. The relevant experience of other EU countries has demonstrated that the preparatory activities should be undertaken on time and should encompass the introduction of CMO measures in phases rather than making rapid and sharp changes. Having that in mind the Republic of Serbia has opted to introduce and implement some of the CMO *measures in* certain carefully chosen sectors in the time period prior to accession. The action envisaged under this document will, to an extent, provide support in attaining the abovementioned goal.

With view to current situation in Serbian agriculture with respect to market conditions for various agricultural products and the needs dictated by the process of alignment with CMO certain sectors have been chosen to acquire pre-accession support under this facility. The choice of fields for intervention has been made in compliance with the Serbian National Program for Agriculture which represents an operational program for the implementation of agricultural policy, consisting of direct payment measures and market measures, as well as specific subsidies and credit support.

Regarding the Milk Sector, action envisaged by this document will provide necessary support to the sector (both to institutions and producers) in order to manage market relation in milk supply (introducing contractual obligations between producers and

processors, establishing producers organizations, applying school milk scheme) and consequently strengthening the competitiveness of domestic milk producers.

When it comes to Animal Production Sector the preparations for the introduction of CMO compliant system needs to start at an early stage of the accession process given the large potential the sector has in terms of favourable natural conditions as well as the, and graveness of problems the sector is faced with. It is of particular importance that this is done in the pre-accession period because it will allow sufficient time for both the relevant authorities and the producers to prepare for the venture on the common market. Also, bee-keeping sector has significant role in CMO in the EU, since its measures combine directs payments schemes, rural development measures and veterinary measures, all contained in the National program of support for bee-keeping sector (that would be based on the Law on organization of agricultural products market).

The cereal sector will be supported by project activities in terms of establishing mechanisms and functioning in the EU common market and harmonization with it. The basic mechanisms that have not existed so far and whose establishment will be worked on are collecting data on prices of certain agricultural products from the cereal sector, creating preconditions for implementing trade policy, especially the system of importexport licenses and tariff rate quotas, market interventions and producer organizations.

As for sugar, after the abolition of production quotas, in addition to market interventions and trade with third countries, the only place where assistance is needed in harmonizing with the acquis is in the area of contractual relations between sugar beet producers and sugar factories, i.e. purchasers.

The situation is similar with tobacco, which, in addition to the part related to harmonization with EU regulations related to producer organizations, also needs help in creating a legal framework related to reporting on the purchase of raw tobacco.

Republic of Serbia is not a significant producer of hops, the areas are small, but there are tendencies of their growth, so it is very important to create an appropriate legal framework related to market standards for hops and procedures related to certification of hops, for which the help of experts is very important.

. Fruit and vegetable sector will be supported by this action in order to achieve full harmonization of the domestic legal framework with the rules governing the subject area in the EU. Currently, the sector is partially harmonized, so it is necessary to continue working on the harmonization of national legislation with the EU acquis. This primarily refers to market standards that exist but are not in line with international standards. In addition, there are producer organizations in the fruit and vegetable sector that are specific and differ from producer organizations in other sectors, primarily due to the existence of operational programs, and it is necessary to pass appropriate regulations related to school fruit schemes, as well. Given the importance of the fruit and vegetable sector for agriculture in Republic of Serbia and the numerous requirements related to the rules and measures for market regulation in this area that need to be transposed into the Serbian legal system, work on these reforms should begin as soon as possible

The Wine, Aromatized Wine Products and Spirit Drinks Sector is in the process of alignment with the CMO rules for some time now, and it is moderately advanced in that respect. Given the fact that the sector has suffered a lot at the end of the 20th century and is recovering slowly it is necessary to complete the alignment with the EU CMO rules (which are currently under reform), in order to prepare the producers for operations on the common European market. All measures, related to wine sector in a member state,

are contained in National program for support of wine sector. To achieve that goal it is essential to fulfil the remaining requirements in terms of transposing and implementing legislation.

Producer Organizations will be requiring support at this stage of accession process because of the very unfavourable conditions in this area. Namely the current structure of Serbian agriculture is fragmented and the majority of producers are small agricultural households. In the aftermath of the accession of the Republic of Serbia to the EU, Serbian producers will be faced with cutting edge competition from well-organized foreign agricultural business subjects. The fact that the development of producers associations in Serbia remains at a low level is alarming, and therefore this action, among other, aims at meliorating the situation with respect to the subject problem by promoting producer organizations, motivating producers to cooperate and organize themselves and creating conditions necessary for their sustainable functioning.

CMO policy treats aid schemes also, especially schemes intended to pre-school and school children, realizing through school fruit and vegetable scheme and school milk scheme. These schemes would be also part of the future CMO framework in Serbia.

Price reporting is significant part of the CMO mechanisms since there are numerous obligation of a member state regarding compulsory price collecting, monitoring and reporting for certain agricultural products. The activities in the future period will be aimed on further harmonization of the current STIPS (Marketing Information System in Agriculture in Serbia) with Marketing Information System in the EU, including harmonization of data sets and methodology, as well as communication with the EC.

Regarding trade with third countries (import / import permits and tariff quotas), the Law on Regulation of the Market of Agricultural Products stipulates that the provisions related to this area enter into force on the day of the accession of the Republic of Serbia to the EU. But, it is certainly necessary for that system to be established by then and for it to be functional. This includes the calculation of customs duties for Non-Annex 1 products (PAPS), which is calculated in a completely different way compared to customs duties for basic agricultural products, so that harmonization is needed in this area as well, because currently in the Republic of Serbia the same way of customs duties is calculated for the basic agricultural products and for processed

.

The MAFWM, namely the Sector for Agricultural Policy, is the key government institution responsible for development and implementation of policies for this sector, in consultation and joint work with other MAFWM organizational units.

3.2 Ongoing reforms:

The project will be implemented within the Sector for Agricultural Policy, the Directorate for Agrarian Payments and the Agricultural Inspection and Phytosanitary Inspection , as well as other relevant stakeholders The legal framework for the implementation of the project will be the Law on Organization of Agricultural Products Market, adopted in June 2021. For the full implementation of the system, it is necessary to adopt a large number of bylaws, so it is planned to start drafting bylaws after the adoption in order to establish the system and be complementary to the market organization system in accordance with Regulation 1308/2013. For the wine sector the legal framework will also be the Law on wine.

The draft of the Law on Organization of Agricultural Products Market was prepared as output of PLAC II and fine-tuning was conducted through ongoing IPA 2015 Technical

assistance project. Law is the legal framework for adopting numerous by-laws, as well as establishing registers and records, empowering the bodies and other issues that will organize market of agricultural products on common way.

For some of the by-laws the legal framework will be law regulating the wine and aromatized wine products sector.

The project should include all activities regarding drafting bylaws such as rulebooks, regulations, guidelines, methodologies, training employees, preparing analysis and studies of certain sectors in order to establish necessary CMO instruments, as well as other necessary activities aimed in creation of functional framework for CMO policy implementation.

3.3 Linked activities:

A several types of expert assistance financed from EU have been used to establish a system related to the harmonization of the domestic legislative framework with the EU acquis in the areas of the Common Agricultural Market Organization (CMO).

Experts were hired through the PLAC II project, which was funded by the EU, to draft the Law on Organization of Agricultural Products Market in accordance with the provisions of Regulation (EU) 1308/2013, and through two projects:

1. Preparation of an analysis of the current situation in the field of regulation of the market of agricultural products in the Republic of Serbia in accordance with Regulation (EU) 1308/2013;

This project was realized during 2014.

The main activities of the project were focused on analysis of the current situation in the field of organizational market of agricultural products in the Republic of Serbia in accordance with the EU Regulation 1308/2013 of the European Parliament and of the Council of 17 December 2013 establishing the common organization of the markets in agricultural products; Introduction of EU requirements for different groups of plant and animal products connected with CMO and draft a proposal for required administrative framework.

2. Drafting of the Law on Organization of Agricultural Products in accordance with Regulation (EU) 1308/2013

This project was realized in the period 2015-2017.

The main activity of the project was assistance in drafting the law on the regulation of the market of agricultural products and accompanying documents. Also, through this project, a draft rulebook on producer organizations was prepared.

3. Beside PLAC II, through the ongoing IPA 15 project "Capacity building for alignment with the acquis in the field of, agriculture, rural development, food safety, veterinary and phytosanitary policy" (Europe Aid / 138038 / DH / SER / RS) the Table of concordance of the Draft Law on Organization of Agricultural Products Marke with Regulation (EU) 1308/2013 has been made. Through this project, a revision of the action plan for Chapter 11 is carried out, where the listed activities are directly related to the project

In the field of viticulture and wine production, harmonization with the EU acquis was carried out through two EU Twinning projects, as follows:

1. Twinning Project "Capacity Building for the Regulation of the Serbian Wine Sector" (Twinning Contract SR-2005-IB-AG-03).

The project began in 2007 and was completed in May 2009.

The main activities of the project were focused on training of MAFWM employees in relation to the then valid EU regulations in the wine sector, and especially related to the establishment of the Viticulture and Wine Registry and laboratory tests, including sensory tests.

2. Twinning Project "Capacity building and technical support for the renewal of viticulture zoning and for the system of designation for wine with geographical indications" (Project Number: SR / 08 / IB / AG / 02).

The project lasted 28 months and was completed in November 2013.

The project enabled the strengthening of the capacity of the MAFWM and the Control Organization for the implementation of the system of geographical indications, collection and analysis of data for zoning of wine-growing areas and creation of regulations governing the area of geographical indications for wines and zoning of wine-growing areas in Serbia in accordance with EU regulations.

Through the ongoing IPA project "Capacity building for alignment with the acquis in the field of, agriculture, rural development, food safety, veterinary and phytosanitary policy" (Europe Aid / 138038 / DH / SER / RS) it is planned to conduct an analysis of the impact of the application " EU CAP "in Serbia related to the wine sector.

In the field of beef and pork production, in the part related to the classification of carcasses on the slaughter line:

Twinning light project "Identification of necessary steps in the process of establishing a system of carcass classification in accordance with EU requirements" was implemented during 2017. The aim of this project was to identify the necessary steps to establish a harmonized system for carcass classification.

In the field of fruit and vegetable sector, for the process of harmonization with EU acquis, technical assistance through the PLAC II project was used, during 2019

The activities were defining general and specific marketing standards of quality for fresh fruit and vegetables, as well as procedures for the control of quality compliance of marketing standards, issuing certificates of compliance with market standards and defining the rules on establishing a database of traders, conditions for entry into the register, exemption of registration, define an authorized trader etc.

The draft version of the Rulebook on marketing standards for fresh fruit and vegetables in accordance with Commission Implementing Regulation (EU) No EC 543/2011 and UNECE standards, which are an integral part of the Common Market in Agricultural Products, has been prepared.

In addition to above mentioned draft, the draft of the Rulebook on the Register of fresh fruit and vegetable traders and Rulebook on inspection and control of compliance of fruits and vegetables with market standards, have also been prepared

In addition to the mentioned projects in the previous period, TAIEX assistance was used through a number of workshops, study visits and expert missions to establish a system related to the regulation of the agricultural products market and its harmonization with the EU acquis.

It is essential that the team, short-term experts included, has broad expertise which will all the areas included in the description of the project.
